CONTEST RULES AND REGULATIONS (the "Rules")

No purchase is necessary to win.

CONTEST PERIOD

The Contest is being held by Brokerlink Inc. (the "Contest Sponsor") and begins Monday, July 19 at 12:01 am EST and closes on Friday, September 10, 2021 at 11:59 pm EST (the "Contest Period"), after which time the Contest will be closed and no further entries will be accepted.

ELIGIBILITY

This Contest is open to residents of Canada outside of Quebec who:

- have an existing personal insurance policy with BrokerLink and Intact Insurance, who are creating a new Client Centre account
- have reached the age of majority in their province at their time of entry in the Contest
- must be a permanent resident of Alberta, Ontario, New Brunswick, Nova Scotia or Newfoundland & Labrador
- [enter the contest, register for Intact Insurance's Client Centre](#) and activate their account *for the first time* during the Contest Period
- are not employees, brokers, agents and representatives of the Sponsor, its affiliated companies, parent companies, advertising and promotional agencies, legal advisors, or parties engaged in the development, productions and distribution of materials related to this Contest, as well as members of their immediate family and/or persons living in the same household during the Contest Period as they are excluded

Please note: Current Intact customers who have already registered for Intact Insurance Client Centre outside of the contest period dates are not eligible for this Contest.

HOW TO ENTER

No purchase required.

To enter the Contest, the Participant must complete the entry form and then register for Client Centre by Intact Insurance for the first time during the Contest Period. The Participant is automatically entered upon completing the entry form and registration, and no further action is required.

THE PRIZE(S)

There will be a total of five (5) prizes available in the form of five (5) e-gift cards worth five-hundred dollars (\$500 CAD) for an aggregate value of two thousand five hundred dollars (\$2,500 CAD)

(hereinafter the “prizes” or individually the “prize. The prizes will be distributed as drawn from a random electronic draw process.

The prize(s) must be accepted as awarded. It (they) cannot be converted into cash, substituted, transferred to another person or refunded, subject to what is provided hereunder.

THE DRAW
